1. **Definition of Confidentiality.** As used in this Agreement, "Confidential Information" refers to any information which has been specifically designated as confidential or secret by the Company or which is otherwise proprietary information, techniques, designs, drawings, models, inventions, know-how, processes, apparatus, equipment, machinery, formulas, compositions, systems, techniques, inventions, machines, computer programs and research projects, and business information relating to Company's products, including without limitation pricing, margin, cost, profit, sales, market share, advertising, promotional, and sales and marketing plans, future business plans and any other information which is proprietary to Company.
